NOTE: Read directions carefully before attempting to assemble:

CLAMP ASSY. (6 EA.)

- 1. Remove components from package and assemble into groups.
- 2. Take sections "G" 3/8" (Telescoping Sections) and insert into sections "E" 1/2" (Element Sections) so overall length will be 100 inches, place clamp in position "F" and tighten. You now have three complete Element Sections.
- 3. Place assembled Elements one at a time on Element Adapter (Fig. "D") and clamp at position "H".
- 4. Place Element Adapter with Elements on Boom Extension (Part "C") and clamp.
- 5. Go to the Director (short) Element end of CHARLES GIZMOTCHY and loosen Element Adapter "A".
- 6. Insert Section "B" of Power Booster in CHARLES GIZMOTCHY and retighten Element Adapter "A". NOTE: It may be necessary to force Section "B" into Section "A".
- 7. Move CHARLES GIZMOTCHY Mast Bracket forward of Driven Elements (Elements with Gamma Match) to maintain center of balance.
- 8. Should it be necessary to adjust either or both Gamma Matches after adapting the CHARLES GIZMOTCHY POWER BOOSTER to your CHARLES GIZMOTCHY Beam, insert a S.W.R. bridge in the feed line and adjust the corresponding Gamma Match for minimum reflected power.

Two #6 x 1/2 metal screws furnished should be used to secure Boom sections together. (See diagram)

Six #4 x 3/8 small metal screws furnished should be used on Element Assemblies to secure a permanent installation.
